The Obligations for AOMEI

- 1.1 AOMEI grants Reseller to obtain the marketing and sales within the region to AOMEI Backup Software including AOMEI Backupper & AOMEI Onekey Recovery and AOMEI Partition Software including AOMEI Partition Assistant, AOMEI Dynamic Disk Manager as well as AOMEI Dynamic Disk Converter.
- 1.2 AOMEI shall allow RESELLER to control its resell price and the price may be lower or higher than the official price provided by AOMEI. But when the resale price is less than 5% of the official price provided by AOMEI, RESELLER needs to gain AOMEI's agreement.
- 1.3 AOMEI provides 40% discount (\$ USD) to RESELLER. Due to VAT, the final payment price may be higher than the discount price provided by AOMEI. If RESELLER has the privilege of exemption, please enter the VAT ID or contact MyCommerce to excuse from VAT when purchasing the product.
- 1.4 AOMEI provides the pre-sales and after-sales support to RESELLER, including all kinds of product brochures, spreadsheets, documents, and so on so that RESELLER shall quickly master the product function and sales skills to better promote work.
- 1.5 AOMEI awards bonus to RESELLER in accordance with the annual sales amount in the form of software license codes, and execute the rebate according to certain standard to RESELLER.

The Obligations for RESELLER

- 2.1 RESELLER can have the online and offline sales channels but is not allowed to have the competitive sales channel like SEO with AOMEI on line
- 2.2 After the termination of the agreement, RESELLER shall not have the right to continue to use any information of AOMEI including trademarks, trade names and other relevant marks.
- 2.3 RESELLER shall not make any representations or warranties in the name of AOMEI.

2.4 RESELLER needs to purchase the software provided by AOMEI via discounted link and then sell them to users.

This agreement will be automatically renewed after the expiration of the first one year valid. After one year of this agreement, both parties shall have the right to terminate the agreement at any time. If RESELLER has the ability and condition to be a gold agent, another agreement shall be signed.

This agreement shall come into force upon signature of both parties, which shall have legal binding. In the event of a breach of any of the provisions of this agreement by one party, the other party is entitled to take protective measures according to the actual situation.
